Introduction

In March 2011, an online survey form was developed to collect information about the facilities in the United States in which official medicolegal autopsies are conducted for the nation's medical examiner and coroner systems. The survey collected information about the names, locations, and types of facilities, as well as general information about the condition of the facilities. Email notification of the survey was sent multiple times to members of the National Association of Medical Examiners (NAME), members of the International Association of Coroners and Medical Examiner (IACME), and Diplomats and Certificants of the American Board of Medicolegal Investigators (ABMDI).

What's included in this report?

- Information from places routinely used by medical examiners and coroners for the purpose of conducting official medicolegal autopsies, whether they be funeral homes, dedicated free-standing facilities, hospital autopsy units, or units within crime labs, law enforcement agencies, or other settings located in the United States including Puerto Rico.
- Military hospitals frequently used by personnel of the Armed Forces Medical Examiner System (AFMES)

What's not included in this report?

- Veteran's hospitals which are occasionally used by the AFMES
- Facilities in which only private, non-official forensic autopsies are performed
- Facilities which exist but did not get reported by survey responders.
- Facilities outside of the United States

Results

324 facilities were identified as follows:

Free standing	151 (48%)
Hospital autopsy facility	105 (32%)
Funeral home	15 (5%)
Within a crime lab facility	12 (4%)
Within law enforcement facility	8 (3%)
Other setting	24 (7%)
Not specified	9

"Other setting" includes a variety of facilities such as re-modeled army barracks, renovated warehouse, basement of judicial building, within a medical facility but not a hospital autopsy area, and several other situations. See list for further details.

272 (87%) of the facilities reported postmortem exam case load data (externals plus autopsies). The total number of annual exams reported was 224,349. That number suggests fairly complete data reporting of facilities as the number of exams approaches 10% of the approximately 2.5 million deaths in the United States annually, and it is commonly accepted that about 20% of deaths should

come to the attention of a medical examiner/coroner and about half of those require postmortem examination.

In terms of facility condition, the responses were as follows:

Thus, 148 facilities (48%) are in need of some renovation or equipment, while 23 (8%) additional facilities report more serious needs. Overall, 171 (55%) have some sort of improvement need.

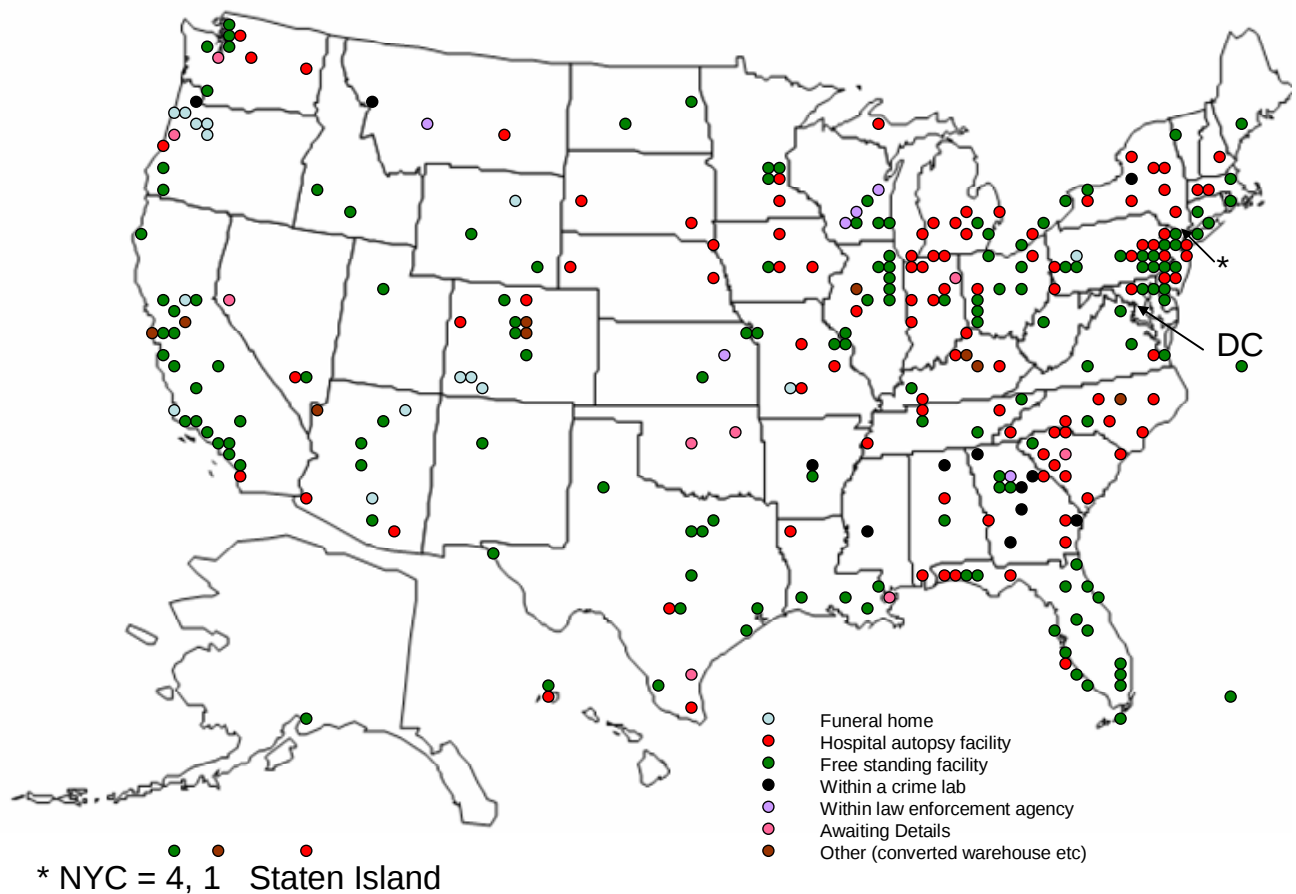
